

support and exhibition terms & conditions

1. ACCEPTING BOOKINGS AND PAYMENT

- The submission of a completed booking form by a representative from your organisation is regarded as a confirmed booking.
- The return of a completed booking form confirms your acceptance of the Support and Exhibition terms and conditions.
- Upon receipt of your booking form, an invoice will be issued for the entire amount of your booking commitment and payment is due within 30 days of the date of invoice (unless otherwise negotiated).
- Bookings will be allocated by the Congress Organiser and confirmed in writing back to participating companies via email. Booth positions will be allocated after taking into account each organisation's partnership level, the date of confirmation of participation, date of payment, preferences and any other relevant matters.
- At its discretion the Organiser may decline any booking. The Organiser's sole liability to any partner or exhibitor whose application is not accepted is to refund to that organisation the fee submitted with the application.

2. CANCELLATION POLICY

- All cancellations must be advised of in writing to the Congress Organiser.
- Any reduction in a sponsorship and/or exhibition allocation (once accepted by the Organisers) will be considered a cancellation and the cancellation policy will apply.
- There is no opportunity to transfer your sponsorship/exhibition booking to another event.
- An administration fee of 50% of the total cost will apply for any cancellations received before and including 1 February 2026. No cancellations will be accepted after 1 February 2026. For any cancellations made after this date, 100% of the cost will be retained.
- Should any payment be outstanding at the time of cancellation, the sponsor/exhibitor is liable for the invoice total as per their acceptance of the terms and conditions and the cancellation policy.

3. INSURANCE

- Any organisation exhibiting at the Congress agrees to obtain and maintain, throughout the duration of the Congress including bump in and bump out times, comprehensive employer liability and public liability insurance.
- It is understood and agreed by each and every exhibitor, its agents and guests that neither the Organiser, its employees nor its contractors shall be liable for loss or damage to the goods or property of exhibitor, its agents and guests. At all times such goods and properties remain in the sole custody and possession of the exhibitor.

4. FLOOR PLAN AND EXHIBITION BOOTHS

- The Organiser reserves the right to vary the floor plan, booth size, booth location or booth allocation and the exhibitor will accept such changes without making a claim for a reduction in exhibition costs.
- Exhibitors agree to not re-assign, share or sub-let the booth or any part of the booth without prior consent of the Organiser.
- For custom stands, all design plans must be approved by the Congress Organiser a minimum of four weeks prior to the exhibition bump in.
- It is the responsibility of the exhibitor to arrange for materials to be delivered to the exhibit hall by the specified deadlines. The Congress Organiser will not take responsibility or provide assistance in signing for or tracking deliveries/pick-ups.
- The exhibitor or his/her agents shall not injure or deface the walls, columns, or floors of the exhibit facilities, the stands, or the equipment or furniture of the stands. When such damage appears, the exhibitor shall be liable to the owners of the property damaged.
- The exhibitor or partner must ensure that all marketing and promotion is confined to the exhibition space allocated.

5. HOURS

- The Organiser will set the precise days and hours that access to the exhibition will take place. Exhibitions must not be dismantled or removed before the set closing time of the exhibition.

6. CONGRESS CANCELLATION OR POSTPONEMENT

- The Organiser may, in its absolute discretion, nominate to either postpone or cancel the event by providing the sponsor/ exhibitor with notice in writing. Cancellation or postponement may be necessary due to acts, events or causes beyond our reasonable control, including, but not limited to, acts of God, industrial disputes, failure in electricity supply or gas supply, war, civil strife, flood, storm, fire, accident, unavailability of raw materials or supplies, explosion, global or national health emergency (including without limitation coronavirus COVID-19), epidemic, breakdown of plant, machinery or equipment or shortages of labour, transportation, fuel, power, plant, machinery, equipment or material.

If the event is postponed to a later date (as nominated by the Organiser and notified to the sponsor), the terms and conditions of this agreement will continue to apply. Any sponsorship contribution paid up to the postponement will be applied to the new event date with any outstanding sponsorship contribution balance due thirty (30) days' prior to the new event date.

7. CONSEQUENTIAL DAMAGE

- The Organiser will not be liable for any indirect or consequential damages arising out of a breach of this Exhibition contract.

8. NAMES

- All company/organisation representatives must be registered online via the Congress website at least three weeks prior to the Congress.

9. HOSPITALITY

- The Congress Partner or exhibitor shall disclose any planned hospitality, promotional, sponsorship or educational activities outside of the Congress, and these activities must not run concurrently to any other Congress activity between 17 - 19 June 2026, unless by prior approval of the Congress Organiser.
- Partners and exhibitors are not permitted to offer any hospitality option which is listed as an item within this prospectus without prior approval of the Congress Organiser.
