President's Report

On behalf of the National Executive Committee (NEC) we are pleased to report that the Society has had continual growth in membership and improved financial security this past year, enabling us to continue to work towards achieving our mission and strategic goals.

Governance

The NEC consists of the President, Past President, Secretary, Treasurer, and State and Territory Representative members. The NEC is supported by two standing committees:

- 1. Research; and
- 2. Education

This year has seen some changes in state representation as terms have ended and one resignation was received. In an effort to continue to support the growth and development of our NEC members a half-day workshop on not for profit governance was held as part of this year's face-to-face meeting. Facilitated by Mr David Osborn (Fellow of the Australian Institute of Company Directors), the NEC underwent practical training on principles of good governance, financial and risk management strategies and better understanding of the legal requirements of a board. Mr Osborn credited the NEC on strong leadership and adherence to good practice in managing the society on behalf of the membership. The NEC acknowledges that facilitating the tremendous growth of CNSA is not without challenge and as the organisation continues

to grow in size and in influence, the NEC is strongly committed to ensuring the governance framework and practices within CNSA are robust and rigorous.

Partnerships and Collaborations

Contribution to and, review of clinical practice guidelines and representation in areas of cancer control has continued this year, with members from all states involved in a range of activities. These include:

- World Cancer Day Cancer Nurse Statement (a joint statement with ISNCC and a
 - number of key international nursing professional organisations)
- Cancer Australia: Ovarian Cancer Clinical Practice Guidelines
- Cancer Australia Lobular Carcinoma In Situ (LCIS) Working Group
- Cancer Australia: Psychosocial Screening of Adults with Cancer Working Group; and
- Victorian Consensus Guidelines for prioritization of access to chemo day services; and
- How International Oncology Nurses are Working Together to Accelerate Progress: A panel discussion at the Union of International Cancer Control UICC Congress in Melbourne 3-6 December 2014.

CNSA continues to be represented in a range of council members/scientific committees, which include:

- Coalition of National Nursing Organizations (CoNNO)
- Asian Oncology Nursing Society (AONS) Advisory Council
- Psycho Oncology Collaborative Research Group (POCOG); and
- Australian New Zealand Urogenital and Prostate Cancer Trials Group (ANZUP).

We thank all CNSA members who participated in these activities, working groups and committees.

The strengthening of established partnerships and the development of new possibilities continues to be a key strategic objective of the NEC. This year we have developed stronger links with The Cancer Institute NSW and EViQ, working in partnership with them for the Central Venous Access Device (CVAD) Guideline review project, and providing forums to further the Antineoplastic Drug Administration Course (ADAC) program. With the International Conference on Cancer Nursing, hosted in Panama in September, CNSA was

well represented at the conference and the Member Council Meeting. CNSA was recognised as a leading cancer nurse organization and provided input into the discussion of international cancer nursing challenges. Additionally sharing our knowledge and our resources with developing societies was a valuable experience, building new connections and support in our region.

Highlights in 2014-15

The 17th CNSA Winter Congress 24th -26th July 2014, hosted in Melbourne attracted more than 500 delegates from around Australia. Themed with Leading in a Time of Change, international key note speaker Dr Theresa Wiseman shared her expertise and knowledge as the Lead for Health Service Research, Nursing, Rehabilitation and Quality, at The Royal Marsden NHS Foundation Trust, London UK and lead investigator on the internationally acclaimed work on Evidence Based Co-Design, an innovative and uniquely patient-centered approach to improving UK health services provision. Congress remains our preeminent event of the year, for members to network, and showcase their achievements.

Other than our Annual Congress, it is also worth celebrating the formation of two Specialist Practice Networks (Cancer Nurse Practitioners SPN and the Vascular Access Device and Infusion Therapy SPN) and a new Regional Group (Queensland Regional Group). The formation of these new groups/networks is a testament to the ever-increasing influence and level of activities within the CNSA across the country.

Executive Officer's Report

It is with pleasure that I present the Executive Officer's report for 2014-15 and reflect on CNSA's efforts towards achieving its mission of promoting excellence in cancer care through the professional contribution of cancer nurses in Australia.

In 2014-15, CNSA continued to focus on five strategic directions and goals. The outcomes achieved in these directions are set out in this Annual Report, including financial results. Given the increased growth and activity in Regional Groups, this annual report presents the past year activities by way of individual reports. There is also the new addition of two Specialist Practice Networks – Cancer Nurse Practitioners and the Vascular Access Device & Infusion Therapy reports for noting.

Membership

The CNSA membership year changed in 2015, from the 1st of April to the 31st of March each year. In the first year of introduction, this meant current financial members received the benefit from a continuation of their 2014 membership, receiving the first three months of 2015 as extra. Quarterly direct debit options have been made available. This new membership year now aligns with the CNSA financial year, this streamlines membership renewal with the current financial and administrative processes, a change endorsed by the CNSA Finance and Audit Committee and supported by NEC.

Since 2012, membership numbers have increased steadily from 480 to reaching a gratifying number of 1100 in March 2015. The Society is growing at a rapid rate and with this pace comes change as the governance and operational tasks adjust.

Website

This reporting period saw CNSA change website providers to IVT Associations Online who work specifically in the non-for-profit sector with clients from member based organisations. In the transfer, modules which have been purchased and included are:

- Publishing
- Responsive web design (for smart phone/tablet)
- Donations Module
- Search Directory
- Community module
- CPD management
- Online payments, direct bank deposit and quarterly deposit payments
- Special promotion field

CNSA Members will be able to take advantage of these new additions such as Member Search Directory, Personalised Continuing Professional Development Profile, Responsive Website Design giving readable and adapted access to <u>www.cnsa.org.au</u> from tablets and mobile phones.

Representation

CNSA have supported and participated in various conferences in the past year. The purpose for CNSA conference representation is to enact three of CNSA's Strategic Directions – to engage membership and building partnerships, to ensure the financial growth of the CNSA, to influence cancer control policy and initiatives. Representation allows the Society to build relationships with national and international partners, discuss strategies and opportunities for joint projects, activities and scholarships and to proactively network with key partners about cancer care issues and cancer care

policy.

Governance

As a national organisation and part of prudent governance, CNSA complies with and reports on regulatory compliance, provides reports for the NEC on financial and risk management, there is also requirement that the Society produce audited financial statements, which are presented to members each year. These financial statements need to prepared on a "consolidated basis" which means not only reporting on the CNSA financial affairs, but also the various Regional Groups and Specialist Practice Networks also. By including Regional Groups and Specialist Practice Networks in this process, the Society is aiming to ensure compliance by working towards concentrating all funds under the broader infrastructure of CNSA, to both gain efficiencies in process and also consistent treatment of income and expenditures. Whilst moving to a financially centralised operation, now and into the future, all Groups will retain their autonomy, the financial delegation of all income, expenditure and activities associated with their group, the funds remain entirely with the individual group and are not used for any other purpose. Separate group reporting will also be provided on a monthly basis.

An effective governance structure enables CNSA to be compliant, provide accountability and have the appropriate control systems to minimise any potential risks. Good governance for CNSA is determining that these systems are in place, including the preparation and audit of the consolidated financial statements for the Society. CNSA has taken these steps to have full disclosure of finances and streamline the administration of your Society, reduce risk and provide protection as CNSA continues to grow and diversify.

Finally, towards the end of this reporting period, the CNSA NEC and members farewelled Sandy McKiernan in her role as President, who in the two year term achieved an enormous amount for the Society, overseeing CNSA to become an independent, self-managed organisation separate from COSA, with a new website, social media, employment of staff, establishing financial and legal structures, substantial Winter Congress growth both in program and attendance, incorporating the bi-ennial National Breast Care Nurse Conference into 2015, tackling the Constitution and finishing off with ever growing membership of over 1,000. I would personally like to thank Sandy for her consistent leadership and dedication to CNSA.

And now we welcome Dr Raymond Chan, who has picked up the reins to run a cracking agenda with his energy, foresight and strategic approach to also lead CNSA into the next exciting phase of growth and development. I look forward to working hard with Ray to deliver an excellent 2015/16 period of advancement.

Thank you to the NEC Office Bearers Ray, Sandy, Trevor Saunders as Treasurer, Anne Mellon as Secretary, Website and Membership Coordinator and NEC members Ellen

This small team work hard throughout the year and give CNSA a very solid group of people that are a pleasure to work with. I look forward to the next reporting year as your Executive Officer.

Treasurer's Report

The 2014-15 reporting period has seen modest increase in the organisation's total financial equity as the National Executive Committee (NEC) and the Finance and Audit Committee (FAC) continue efforts to build the financial sustainability of the CNSA.

The CNSA Annual Winter Congress continues to attract strong attendances and sponsorship with the majority of the organisation's 2014-2015 income coming from this activity, generating a net profit in excess of \$168,900. The Winter Congress Committee (WCC) has worked diligently with our professional conference organiser to meet the strategic goal of increasing attendance at and revenue from Winter Congress. Financial reporting of associated revenue and expenditure is now more transparent, clearly demonstrating the contribution of this annual event to securing financial sustainability, an important strategic action to enable the growth of the society.

Membership subscription income has this year grown, consistent with an increase in new members, amounting to \$93,970 for the year ending 31 March 2015. Maintaining membership growth and providing our members with benefits and services underpin a budget strategy that seeks to facilitate achievement of strategic goals to grow the CNSA membership and to provide members with opportunity to develop the knowledge and skills to effectively contribute to cancer control.

The CNSA continues to receive modest donations, amounting in 2014-15 to \$12,300, in support of our strategic direction of facilitating cancer nurses' professional development irrespective of their geographical location across Australia. The financial sustainability and growth of the society has enabled an increased allocation in 2015-2016 toward facilitating professional development through our grants and awards program, together with a budgeted allocation to special projects to develop professional development resources and activities. Identifying new philanthropic and industry partners will be essential to expanding our grants and awards scheme and related member benefits and will in future be guided by a sponsorship policy, to be developed in the coming year.

Amounts held in investment have increased to over \$490,000 in 2014-2015, earning modest returns of just under \$18,000. Policy work to be commenced in the next year by the FAC will see the promulgation of an ethical investment policy, aimed at protecting and increasing the organisation's assets through careful investment.

Overall, the financial position of the CNSA remains healthy with a total equity of \$519,921 and an operating surplus of \$30,571 for the year ended 31 March 2015. Sustaining a rigorous governance and strategic framework has been the focus of the FAC and the NEC during this reporting period. With the recent growth of the organisation there has been renewed attention on the organisation's financial processes, controls and arrangements for financial reporting. As an incorporated association in Australia, the CNSA is required to satisfy the financial and reporting requirements of the Associations Incorporation Act 1991 (ACT), in addition to complying with requirements specified by the Australian Accounting Standards. The accompanying annual financial report, statements and notes reflect these disclosure requirements, for the first time itemising the activities of our regional groups and specialist practice networks.

Communications Report

The CNSA social media profile has continued to grow over the past year. The CNSA Twitter feed and Facebook page continue to serve not only as a platform for regular communication and news to our members but also to attract new members. The Twitter feed has 605 followers, which is an increase of 73 followers. The CNSA Facebook page currently has 761 likes, which has also seen an increase of 159 likes.

Chilli Fox Events continues to maintain the social media platform for CNSA along with the Communications portfolio holder on the NEC. A social media plan has been developed with monthly themes, member profiles, Throwback Thursday and Fact Friday, as well as posting relevant news stories and information from like-minded organisations. Social media themes highlighted over the past year have included prostate cancer, mental health, breast cancer, cervical cancer, radiotherapy, infection prevention, risk factors, ovarian cancer, Indigenous people, melanoma and leadership in nursing.

The publication of the newsletter continues to be an important part of the CNSA communication strategy. This is distributed via email to CNSA members and posted on the website, with contributions from Regional Groups, Specialist Practice Networks and Education and Research committees.

17th Annual Winter Congress Report

The Pullman Hotel in Albert Park, Melbourne played host to 497 delegates attending the 17th Winter Congress of the Cancer Nurses Society of Australia between July 24 and 26, 2014.

The expertise and enthusiasm of the Melbourne Local Organising Committee (LOC) made up of Jac Mathieson (Chair), Judy Forsyth, Tina Griffiths, Nicole Kinnane, Mei Krishnasamy, Donna Milne, Cathie Piggott and Georgina Wiley saw Winter Congress 2014 deliver a program that attracted cancer nurses from across the country, independent of sector, discipline or geographical location.

The draw card for the 17th Winter Congress was the acclaimed and engaging international keynote speaker, Dr Therese Wiseman. Dr Wiseman inspired delegates with insights into her innovative patient-centered approach to improving health services provision in the UK. She challenged delegates to advocate for patient inclusion, where decision-making affected patient lives, delivering on the Congress theme "Leading in a time of Change".

The 2014 program included a wealth of speakers from clinical experts to those who had dedicated their careers to understanding and advocating for those people with cancer who are marginalised and who often experience poorer health outcomes. Associate Professor Gail Garvey explored the issues facing indigenous people requiring cancer treatment and care. Adjunct Associate Professor Kim Ryan left delegates contemplating their role as nurses in improving the patient journey through better mental health care. Invited national speakers included Professor Claire Rickard, Professor Grant McArthur and Associate Professor Karin Thursky who provided delegates with evidence based updates on clinical practices and issues facing patients and the role of nurses in addressing these issues.

Winter Congress came of age in 2014 with the incorporation of the interactive Congress App, allowing delegates to rate sessions, make notes, develop their own personalised programs and collect details and information from both colleagues and industry representatives.

Abstract submissions rose to 93 from 87 in the previous year. Of those, 49 were accepted for podium presentation and 20 were accepted for poster presentation. With the withdrawal by some presenters, 47 abstracts were presented by podium and 19 posters by display. Four prizes were awarded, Best Clinical Practice Paper won by Leisa Brown, Best Clinical Research Paper won by Dr Raymond Chan, Best Poster Award won by Lorna Rogers and First Time Presenter Award, won by Polly Dufton. All prize recipients were awarded a cash prize of \$250.

More than 75% of delegates registered by the close of early bird, enjoying a discounted rate for their early registration. An organisational rate was offered for the first time in 2014, which enabled organisations to purchase one registration and share it within the workplace. This offering however did not prove to be successful with only 2 organisations taking up this initiative.

CNSA marketed Congress through numerous avenues including Facebook, Twitter, use of promotional Congress slides by Regional Groups, Congress flyers and posters, regular e-blast notices and advertising through various societies including COSA, ISNCC, Cancer Institute NSW, Palliative Care Australia, Lung Foundation, Australian College of Nurse Practitioners, Australian Practice Nurses Association and the New Zealand Nurses Organisation.

17th Annual Winter Congress Report continued...

An unprecedented level of industry support ensured that Congress 2014 was a huge success for CNSA as a society. The large exhibition was supported by 2 major supporters, BMS and Hospira, 4 congress partners, Amgen, Celgene, Roche and Sanofi in addition to 37 exhibitors and 2 not for profit organisations. The program ran for 3 days and offered delegates a choice of 4 pre-Congress workshops, 3 concurrent Congress streams, 2 industry supported breakfast sessions and a poster display hosted amongst exhibitors. In addition, delegates and exhibitors were offered the opportunity to mingle with colleagues and friends at the Welcome reception and at the Congress dinner. More than half of all delegates enjoyed the welcome reception and 138 attended the Congress dinner. The dinner for 2014 strayed from the gala format and took on a circus theme in a stand up, food station format. The feedback on the dinner identified that the traditional gala format was a more popular option amongst delegates.

To engage with industry the exhibitor passport competition was repeated in 2014. An iPad mini was offered as the industry passport prize, which inspired hundreds of delegates to actively engage with industry throughout the exhibition space. This initiative again proved successful as evidenced by industry evaluation and feedback.

Winter Congress 2014 was the most financially successful congress in history. A total of \$268,875 was generated in support, registration and exhibition, up more than \$50,000 from 2013. After disbursements and management fees were paid, CNSA netted a record profit for 2014 of \$169,963.96. The success of Winter Congress in Melbourne can be attributed to a diverse and balanced program developed by a dedicated LOC, the hard work of the Winter Congress Committee and the tireless efforts and commitment displayed by the Professional Conference Organisers, Chillifox events.

In 2015, The 18th Annual Winter Congress will be hosted in Perth, led by LOC Chair Dr Ruth McConigley. For the first time, 2015 will incorporate the National Breast Care Nurse Conference into the their new conference home of CNSA Winter Congress.

Education Standing Committee Report

The Education Standing Committee continues to act in an advisory role to the NEC by providing expert knowledge, advice and information on matters relevant to cancer nursing education and the recognition of the specialist cancer nurse role.

Key outcomes of the group in the last reporting period include:

- Presentation of the findings of scoping working at CNSA Winter Congress 2014 Recommendations by CNSA Education Standing Committee regarding Enrolled Nurse (EN) administration of antineoplastic agents. This work was the culmination of work of the committee over the last two years. Based on this report, a COSA Council Discussion Paper was presented at the COSA Council meeting in March 2014.
- Drafting of a paper for publication based on the "EN antineoplastic agent administration" scoping work.
- Administration of two grant rounds:
 - o September 2014 (11 applicants total)
 - Pam Renouf Memorial Study Award recipients Kath Schubach, Gillian Blanchard and Carla Thamm (\$12,300 awarded)
 - This is the last year CNSA will offer the Pam Renouf Memorial Study Award. The CNSA, with the support of the Estate of Pamela Joyce Renouf, has awarded almost \$50,000 in funding over the last six years. In line with the instructions for the use of the funds, one of the awards was to be made to an Aboriginal or Torres Strait Islander nurse. Despite active promotion of this category of the award no applications have been received. The CNSA NEC has recommended holding over \$2000 of funding that will be allocated to support an Aboriginal/Torres Strait Islander grant in the future. The CNSA Education agrees with this approach.
 - o March 2015 (14 applicants total)
 - Ipsen grant recipients Sarah Northfield and Julie Flynn (\$3,275.70 awarded)
 - The WA Regional Group grant recipients Susanna Murphy, Holly Elliot, Fleur Holland, Russell Reyes (\$2,400 awarded); and Cancer Council Victoria Breast Care Travel Grant Laura Levett (\$2,000 awarded).

The past year for the CNSA Victorian Regional Group (CNSA VIC RG) has been an exciting one with terrific attendance and enthusiasm at the educational evenings. First of all the CNSA Breast Oncology Specialist Practice Network (Breast SPN) would like to acknowledge the outstanding contribution that Lis Black has provided to the Network in her role of Chair. They comprise of clinical nurses, advance practice nurses, nurses working in quality improvement, nurse managers, nurse educators and nurse researchers. All states of Australia are represented.

We will hold our first Annual CNSA VAD&IT SPN General Meeting at the CNSA Winter Congress in Perth this year. This will provide an opportunity for cancer nurses interested in vascular access to meet and decide the direction of our SPN. There is also a Pre-Congress workshop, a breakfast workshop and four oral abstracts relating to vascular access at the 2015 Winter Congress.

The CNSA VAD&IT SPN will provide resources to ensure that cancer nurses are providing evidence based care to improve VAD insertion and maintenance to prevent failure. We will take over the role of reviewing and updating the CNSA CVAD Guidelines. The CNSA VAD&IT SPN plans to collaborate with their local CNSA groups, Haematology Society of Australia and New Zealand Nurses Group, Australian Vascular Access Society, Alliance for Vascular Access Research and Training Group, eviQ, universities and industry.

Vascular access insertion is a common procedure for all patients undergoing treatment for cancer. Maintenance and intravenous therapy administration is predominantly the role of nurses. Interest in vascular access is popular amongst cancer nurses so we hope to increase the numbers of nurses joining the CNSA VAD&IT SPN by 2016.

The Cancer Nurses Society of Australia Incorporated Notes to the Financial Statements For the year ended 31 March 2015

Note 1. Statement of Significant Accounting Policies:

The Executive Committee members have determined that the Society is not a reporting entity and accordingly, this financial report is a special purpose report prepared in order to satisfy the financial and report preparation requirements of the Associations Incorporation Act 1991 (ACT).

The Society is an incorporated association domiciled in Australia. All amounts are in Australian dollars.

The financial report has been prepared in accordance with the recognition and measurement requirements specified by the Australian Accounting Standards and interpretations issued by the Australian Accounting Standards Board (AASB) and disclosure requirements of:

AASB 101	Presentation of Financial Statements
AASB 108	Accounting Policies, Changes in accounting estimates & errors
AASB 110	Events after the reporting period
AASB 1031	Materiality

The financial report has been prepared on an accruals basis and (except as noted below) is based on historical costs. Unless otherwise stated, the accounting policies adopted are consistent with those of the prior year.

The accounting policies that have been adopted in the preparation of the statements are as follows:

(a) Revenue Recognition:

(i) Donations

The Society, in common with most organisations dependent upon contributions, is unable to establish control over voluntary donations prior to their initial entry into the accounting records, therefore they are recorded on the basis of cash received.

(ii) Member Subscriptions

Member subscriptions are recorded on an accruals basis and apportioned across the calendar year of membership.

(iii) Grants and Bequests

The Society receives grants and bequests for certain activities. Where a grant or bequest is non-reciprocal, it is recognised as revenue of the Society upon receipt. Associated expenditure for the completion of a grant or bequest is recorded as incurred. Where a grant or bequest is subject to a reciprocal transfer, a liability associated with the reciprocal transfer is recorded upon receipt of the transfer. The income and expenditure is then subsequently reported at the time of the subsequent of the grant or bequest.

(iv) Net Congress Income

The Society contracts a professional Events Co-ordinator to manage the staging of the Annual Winter Congress including the receipt of revenue and payment of expenses in relation to the event. Documents detailing the income and expenses have been received from the Events Co-ordinator together with a reconciling statement. Revenues and expenses associated with the Congress are recognised through the Statement of Profit & Loss and Other Comprehensive Income in the year the Congress is conducted. In the period in the lead up to the congress, expenditure is incurred and income received which is taken up as prepayments and unearned income respectively.

(b) Income Tax:

The Society is exempt from the payment of income tax pursuant to Section 50-5 of the *Income Tax Assessment Act* (1997).

(c) Cash and Cash Equivalents:

Cash and cash equivalents include cash on hand, deposits held on call with banks and other short-term highly liquid investments with original maturities of three months or less.

(d) Income in Advance:

Income in Advance includes member subscriptions, which have been received for the 2015 membership year, (Refer to note 1 (a) (iii)) and congress income received (Refer to note 1 (a) (iv)) or other future income such as sponsorships, which may cover the full proceeding calendar year.

(e) Goods and Services Tax:

Transactions are recognised net of GST, except where the amount of GST incurred is not recoverable from the Australian Taxation Office (ATO). Receivables and payables are stated inclusive of the amount of GST receivable or payable. The net amount of GST recoverable from, or payable to, the ATO is included with other receivables or payables in the balance sheet.

(f) Comparative Figures:

Comparative figures have been adjusted to conform to changes in presentation for the current year where required by accounting standards or as a result of changes in accounting policy.

(g) Property, Plant and Equipment:

Property, plant and equipment is initially recorded at the cost of acquisition or fair value less, if applicable, any accumulated depreciation and impairment losses. Plant and equipment that has been contributed at no cost, or for nominal cost, is valued and recognised at the fair value of the asset at the date it is acquired. The plant and equipment is reviewed annually by Executive Committee members to ensure that the carrying amount is not in excess of the recoverable amount from these assets. The recoverable amount is assessed on the basis of the expected net cash flows that will be received from the utilisation of the assets and the subsequent disposal. The expected net cash flows have been discounted to their present values in estimating recoverable amounts.

(h) Other Current Assets:

Prepayments included in other assets primarily relates to prepayments for the future Winter Congress.

(i) Trade and Other Payables:

Trade and other payables represent the liabilities for goods and services received by the Society that remain unpaid at 31 March 2015. Trade payables are recognised at their transaction price. They are subject to normal credit terms and do not bear interest.

(J) Employee Benefits:

Provision is made for the liability for employee entitlements arising from services rendered by employees to 31 March 2015. Employee benefits have been measured at the amounts expected to be paid when the liability is settled, plus related costs.

Note 2. Nature and objects of the Society:

The Society is an association incorporated under the *Associations Incorporation Act 1991*. Its object is to determine and regulate professional standards and competencies for cancer nursing practice and education, facilitate research and standards in the area of cancer nursing, act as a resource for the development and dissemination of information relating to new technologies in cancer nursing, ensure that cancer nurses perspectives' are evident in national nursing debates, actively lobby government on issues relevant to cancer nursing and collaborate locally, nationally and internationally with other organisations involved in the development and provision of services to people with cancer.

In the event of the Society being wound up, the members undertake to contribute to the assets an amount not exceeding the ordinary membership fee of the Society.

The ability of the Society to maintain its operations is dependent inter alia on continuing support of its members by way of voluntary subscriptions
