President's Report

Over the past 12 months, the National Executive Committee (NEC) has farewelled several key members who have made a significant contribution to both the profession of cancer nursing and to the CNSA. These members included Sandy McKiernan, Anne Mellon and Angela Mellerick.

The NEC acknowledges the tremendous growth in membership over recent years, with the latest membership count of 1207. The NEC has worked tirelessly over the past 12 months to strengthen the governance and infrastructure of the CNSA, to ensure that the CNSA will continue to meet its strategic objectives. At the end of 2015, the NEC commissioned



a review of the CNSA Constitution and the appropriateness of its legal structure. To ensure the success of this project, the NEC has (i) engaged an experienced consultant company - Association Forum, and (ii) endorsed the formation of the CNSA Constitution Review Steering Committee (CRSC). Sandy McKiernan (CNSA Immediate Past President) has been appointed to chair this steering committee. The full committee comprises:

This project is expected to take place over the next 12 months and will facilitate an enormous amount of consultation with members.

The new groups established over the past 18 months, including the Queensland Regional Group (QLD RG), Vascular Access Device & Infusion Therapy Specialist Practice Network (VAD&IT SPN) and the Cancer Nurse Practitioner Specialist Practice Network (CNP SPN), have certainly added a new level of vibrancy to the society. Over the past 12 months, the Regional Groups (RGs) and Specialist Practice Networks (SPNs) have delivered over 26 face-to-face educational events across the nation. Additionally, CNSA awarded a total of 18 grants to CNSA members to participate in a number of national and international educational events and 2 Special Project grants that were open to all existing CNSA groups. I thank all the relevant committees for their continuing efforts in ensuring that our members have the best professional development opportunities possible.

During June 2015, the CNSA held its 18th Winter Congress "Cancer Nursing: Expanding Possibilities"; with a record breaking attendance in excess of 600. For the first time, the CNSA incorporated the National Breast Cancer Care Conference into its Annual Congress. I would like to thank Sam Gibson and the Local Organising Committee (LOC) for their tremendous efforts for making the 2015 Winter Congress a great success.

Development of resources and representation in different areas of cancer control continues to be a focus for the CNSA. Over the past 12 months, the CNSA represented at a range of committees and organisations, which included the Cancer Australia Intercollegiate Advisory Committee, Clinical Oncology Society of Australia (COSA) Executive Council, Coalition of National Nursing and

Midwifery Organisations (CoNNMO), Psycho Oncology Collaborative Research Group (PoCoG); and Australian New Zealand Urogenital and Prostate Cancer Trials Group (ANZUP). The CNSA also endorsed a number of resources including but not limited to the below:

- COSA Tele-oncology Guidelines
- COSA Cancer Care Coordination Position Statement
- World No Tobacco Day Joint Statement 2015
- ISNCC Tobacco Position Statement; and
- Best Practice Principles for Caring for Patients Undergoing Radiotherapy.

Thank you to all CNSA members who participated in the development or the endorsement process of these important resources.

The strengthening of key partnerships continues to be a key strategic goal of the NEC. In 2015, we developed stronger links with eviQ, the McGrath Foundation and the ANZ Lung Cancer Forum. The collaborative work with eviQ, to locate and appraise current evidence-based clinical guidelines for the management of central venous access devices (CVAD) in cancer patients, has been extremely useful. This work has not only resulted in a point-of-care practical resource for clinicians (available on the CNSA and eviQ websites), but also informed phase 2 of the project. Nicole Gavin and I have recently secured support from Cancer Council Australia (CCA) to develop the CNSA CVAD guideline using the CCA Wiki-platform. We thank Professor Sanchia Aranda and her team for their enthusiastic support. Nicole Gavin will be leading a team of members with expertise in guideline development and CVAD management in developing this important resource.

Over the past few months, the CNSA has entered into two separate Memorandums of Understanding (MOUs) with the McGrath Foundation and the ANZ Lung Cancer Nurses Forum. These MOUs have formalised the meaningful partnerships between the CNSA and our partners, especially in the efforts of providing high quality national professional development to nurses who specialise in breast cancer and lung cancer care.

I am also very pleased to report that in November 2015, I represented the CNSA at the Asian Oncology Nursing Society (AONS) Conference, held in Seoul, Korea. At this conference I focused on establishing new strategic links with our partners in Asia and continued the conversations on how nurses will continue to maximise our impact on cancer control in the Asia Pacific region. In one of the plenaries I discussed the importance of and lessons learnt on "Building Capacity for Research and Knowledge Translation at the Organisational Level". Professor Patsy Yates presented her plenary address on "Nurses' Contribution to Improved Outcomes in Survivorship". I am very pleased with the Australian representation at this year's AONS Conference, as well as the new partnerships formed during this event.

Last but not least, I would like to extend my heartfelt congratulations to Professor Patsy Yates for her recent appointment as incoming President Elect for the International Society of Nurses in Cancer Care (ISNCC), and Professor Sanchia Aranda for her ISNCC Distinguished Merit Award. The CNSA is extremely proud of the achievements of these two senior leaders in cancer nursing, and has been very honoured to be able to nominate the both of them for these well-deserved honours. I thank the members who were involved in contributing towards these important nominations.

It has been a huge year with many great outcomes. I look forward to working with the NEC, staff and members to further the mission of the CNSA.

Executive Officer's Report

I am pleased to present the 2015-16 Cancer Nurses Society of Australia (CNSA) Executive Officer's Report.

Over the course of the 2015-16 financial year, CNSA continued the ongoing development and growth to the benefit of members and stakeholders. CNSA's work in 2015-16 was guided by the Strategic Plan, which sets the direction for the Society.

Since 2012, CNSA has had unprecedented growth of members, increasingly successful congress events and employed staff to take charge of the operations of the society. As a result, CNSA need to work



within a governance framework that strengthens and enables building for the future. An updated and contemporary Constitution will be the foundation for future growth of the CNSA.

Constitution Review

CNSA is currently an Incorporated Association, under the Associations Incorporations Act (1991) of the Australian Capital Territory. The Act gives structure and rules by which to establish and govern the society. The CNSA Constitution was first written in 1998; along the way there have been minor changes. The constitution was written at a time when the member numbers and the operations of the society were very different from today, it is now timely to review and consider whether to apply contemporary practice to the governance of our society.

CNSA National Executive Committee (NEC) established a Constitution Review Steering Committee (CRSC) and engaged an external consultant (Associations Forum), for the exclusive purpose of a full-scale review of the Memorandum and Articles of the Association of the Cancer Nurses Society of Australia Incorporated, to provide recommendations on changes to the current Constitution.

The CRSC reviewed each section of the current Constitution, considered governance best practice, discussed the needs of the CNSA and reflected upon how any changes may be considered by the membership. All proposed change was backed by a strong rationale for the benefits of doing so, resulting in the Overview Document upon which an updated Constitution will be written. Over the next 12 months, members of CNSA are invited to make comment and contribute to the development of this document.

Centralising Financials

As part of good governance, CNSA moved to a financially centralised system during the reporting period. By including Regional Groups (RGs) & Specialist Practice Networks (SPNs) under the broader infrastructure of CNSA, this has now ensured compliance with the highest accounting standards, including the Goods & Services Tax (GST) and associated regular reporting requirements that must be completed by a Not for Profit charitable organisation. Each month RGs and SPNs are provided with the financial reports, profit and loss to inform their committees.

Representation

In line with CNSA's Strategic Directions: to engage membership and building partnerships, to ensure the financial growth of the CNSA, to influence cancer control policy and initiatives, CNSA continued to strengthen its presence at various conferences and meetings. This representation

allows the Society to build relationships, establish Memorandums of Understanding (MoUs), and discuss strategies and opportunities for joint projects, educational activities, scholarships and to network about cancer care issues.

This increased representation nationally and internationally over the last five years has raised the CNSA profile, increased membership, identified leaders to attend CNSA events and establish formal agreements to achieve and serve mutual goals and/or reciprocal arrangements to minimise cost to both organisations. This activity has proven results to benefit your Society.

Annual Congress Professional Conference Organiser

Tender proposals were invited for the position of Professional Conference Organiser (PCO) to organise the 20th, 21st and 22nd CNSA Annual Congresses in 2017, 2018 and 2019. Three tender proposals were received. Based on the selection criteria including fees, capacity to provide service, representation, availability and a good fit with CNSA, Chilli Fox Events has been engaged as the CNSA PCO from 2017-1019.

Membership Strategy

CNSA as an organisation has many strengths within its current membership, which has increased considerably in the past few years (129% over four years), however there remains the opportunity to implement strategies to enhance membership benefits and expand membership numbers. All of which contribute to the overall professional base of CNSA and to fiscal outcomes. Accordingly, a workgroup was formed to develop the CNSA Membership Strategy, members of the workgroup are Jane Campbell, Anne Mellon and Julie Calvert. The Membership Strategy was developed in response to the membership survey where opportunities were identified and conform to the CNSA Strategic Directions: to engage membership and building partnerships and to ensure the financial growth of CNSA.

Treasurer's Report

On behalf of the National Executive Committee (NEC) and the Finance and Audit Committee (FAC), I am pleased to inform members that the 2015-2016 reporting period has once again seen sustained growth in the organisation's total financial equity.

Continued growth in membership subscription income, amounting to almost \$142,000 for the year ending 31 March 2016, has more than adequately met the organisation's administration expenses. Growth in membership subscription income comes from both increased membership numbers and an increase in membership dues. A budget strategy underpinned by the Society's strategic goals aims to maintain



steady membership growth and to enable members to receive the benefits and services of being part of Australia's peak body for nurses in cancer care.

In support of our mission to facilitate the professional development of cancer nurses, the CNSA continues to attract generous amounts in sponsorship of Regional Group (RG) and Specialist Practice Network (SPN) activities and our grants program, totalling \$19,700 in this reporting period. As we look to build the financial sustainability of the CNSA, the NEC and FAC plan to work strategically to build partnerships and identify benefactors that will enable us to diversify the sources of income required to meet our goal of providing members, irrespective of geographic location across the nation, with opportunities to develop the knowledge and skills necessary to effectively contribute to cancer control.

The 2015 CNSA Winter Congress in Perth exceeded expectations, attracting strong attendances and sponsorship and as in previous years contributed the majority of the organisation's 2015-2016 income, reporting a net profit of just over \$194,000. The Winter Congress Committee (WCC) worked diligently with our Professional Conference Organiser (PCO) Chilli Fox Events to ensure this key annual event represents both high quality and high value.

Funds held in investment have increased to over \$505,000 in the 2015-2016 year, earning modest returns of just over \$15,100. The NEC and FAC have a key responsibility to members to maintain and extend the assets of the organisation, to enable us to take a leadership role in addressing the educational needs of nurses in cancer care, develop and disseminate resources which contribute to advances in cancer nursing practice, facilitate cancer nursing research and to ensure we contribute to cancer control activities and policy. In its stewardship of the CNSA's financial assets, the NEC and FAC have this year promulgated and adopted an investment planning policy and procedure to support this aim. The financial growth of the society enabled an increased allocation in 2015-2016 toward our grants and awards program, together with a budgeted allocation to a Special Projects program to develop professional development resources and activities. Whilst uptake of these opportunities continues to grow, the NEC and FAC plans to make use of the income generated from our considerable assets to provide for more such initiatives in the future.

Overall, the CNSA remains in a sound financial position with a total equity of \$688,515 and an operating surplus of \$129,860 for the year ended 31 March 2016. As an incorporated association in Australia, the CNSA is required to satisfy the financial and reporting requirements of the Associations Incorporation Act 1991 (ACT), in addition to complying with requirements specified

by the Australian Accounting Standards. The accompanying annual financial report, statements and notes reflect these disclosure requirements.

Website and Communications

The CNSA social media platform has continued to grow over the past year, striving to build the profile of CNSA. The CNSA Twitter feed and Facebook page serve as a platform for regular communication and news to our members, as well as attracting new members. The Twitter feed has 717 followers, which is an increase of 112 followers. The CNSA Facebook page currently has 1106 likes, which has also seen an increase of 345 likes.



The CNSA Communications Officer, in collaboration with the Secretary, Website and Membership Coordinator and Executive Officer, works with Chilli Fox Events to maintain the social media platform. A social media

plan has been developed with monthly themes, member profiles, Throwback Thursday and Fact Friday, as well as posting relevant research, news stories and information from like-minded organisations. Social media themes highlighted over the past year have included Human Papilloma Virus, distress, oncologic emergencies, chemotherapy, breast cancer, advanced practice, pancreatic cancer, paediatric oncology, radiation therapy, ovarian cancer, melanoma and lymphoedema.

The publication of the newsletter continues to be an important part of the CNSA communication strategy and from September 2015 the CNSA newsletter has gone online. The CNSA E-Newsletter is distributed via email to CNSA members as well as being posted on the CNSA website. 18th Winter Congress Report

The Perth Convention and Exhibition Centre played host to a record number of 619 delegates attending the 18th Winter Congress of the Cancer Nurses Society of Australia (CNSA) between June 14 and 16, 2015.

The expertise and enthusiasm captured by the members of the Perth Local Organising Committee (LOC), made up of Dr Ruth McConigley (Chair), Sam Gibson, Sandy McKiernan, Narelle Smith, Nicole Newell, Therese Thompson, Sara Jaenke and Sharon Ray saw Winter Congress 2015 deliver a program that attracted cancer nurses from across the country, independent of sector, discipline or geographical location.



For the first time in Congress history, delegates were able to hear from three international cancer experts. Dr Carrie Tompkins Stricker, a Nurse Practitioner from Pennsylvania and an expert in breast cancer care and survivorship, discussed cancer nursing opportunities beyond the bedside and provided insights into global opportunities for nurse-led

opportunities beyond the bedside and provided insights into global opportunities for nurse-led care. Professor Alex Molasiotis, a renowned cancer nurse researcher from Hong Kong Polytechnic gave a keynote presentation on "Expanding the role of the Advanced Practice Nurse, the legal and professional perspectives". Our third international speaker was Professor Lesley Fallowfield from the University of Sussex, UK who is an expert in quality of life measures and communication skills training for health care professionals.

A new addition to Winter Congress for 2015 was the incorporation of the National Breast Care Nurse Conference. This provided clear breast specific streams for delegates to attend such as the Breast Cancer Care Pre-Congress Symposium, a concurrent session featuring invited breast cancer experts and a concurrent session of abstract presentations focusing on breast cancer. CNSA would like to acknowledge the efforts of Kerry Patford, Chair of the CNSA Breast Specialist Practice Network (Breast SPN), for all of her help and guidance with coordinating the breast cancer stream.

The Congress Program was developed predominately by the Winter Congress Committee (WCC) and the LOC. The program began with six concurrent Pre-Congress Workshops on Sunday 14 June followed by the Welcome Reception. The 2015 Welcome Reception also saw the acknowledgement of CNSA Past Presidents, recognising the significant contribution these people had made in leading and growing CNSA. The main Congress program took place for two full days on Monday 15 and Tuesday 16 June 2015. The program consisted of 4 breakfast sessions, five plenary sessions and 12 concurrent sessions that featured a blend of abstract presentations and invited speakers. The CNSA Annual General Meeting and CNSA Specialist Practice Network (SPN) Meetings were also held during Winter Congress.

Abstract submissions rose to 108 from 93 in the previous year. Of those, 48 were accepted for podium presentation and 34 were accepted for poster presentation. Five prizes were awarded, Best Clinical Practice Paper won by Catherine Barratt, Best Clinical Research Paper won by Sharron Carson, Best Poster Award won by Kylie Ash, First Time Presenter Award won by Corrie Miles and the Audience Choice Best Poster Award won by Meagan Taylor. All recipients were awarded a cash prize of \$250.

CNSA marketed Congress through numerous avenues including Facebook, Twitter, use of promotional Congress slides by Regional Groups, Congress flyers and posters, regular e-blast notices and advertising through various societies including the Clinical Oncology Society of Australia (COSA), International Society of Nurses in Cancer Care (ISNCC), Cancer Institute NSW, Palliative Care Australia (PCA), Lung Foundation, Australian College of Nurse Practitioners (ACNP), Australian Practice Nurses Association (APNA) and the New Zealand Nurses Organisation (NZNO).

The 2015 CNSA Winter Congress received a total of \$393,790 in sponsorship and exhibition sales, which was an increase of over \$120,000 from the 2014 Winter Congress. This is a record for the CNSA. The large exhibition was supported by four major supporters, Hospira, MSD, BMS and Roche, six congress partners, Amgen, Celgene, Breast Cancer Network Australia, Cancer Council, Gilead and Sanofi in addition to 42 exhibitors.

To engage with industry, the exhibitor passport competition was repeated in 2015. An iPad mini was offered as the industry passport prize that encouraged delegates to actively engage with industry throughout the exhibition space. This initiative again proved successful as evidenced by industry evaluation and feedback.

The 2015 Gala Dinner was held at the Perth Convention Centre and reverted back to the traditional sit-down, three-course meal format following feedback received from delegates in 2014. Winter Congress 2015 was the most financially successful Congress in CNSA's history. After disbursements and management fees were paid, CNSA netted a record profit for 2015 of \$225,958.88 (inc. GST). The success of Winter Congress in Perth can be attributed to a diverse and balanced program developed by a dedicated LOC, the hard work of the WCC and the tireless efforts and commitment displayed by the Professional Conference Organiser (PCO), Chilli Fox Events.

In 2016, The 19th Annual Congress will take place at the Cairns Convention Centre from the 12th - 14th May 2016. As the congress will be held in May (not Winter), CNSA has decided to rename the congress to the CNSA Annual Congress.

The Committee has met bimonthly during the reporting period and has been active in research related activities including support of the New Researchers Workshop at Winter Congress (WC) in Perth in collaboration with the Local Organising Committee (LOC), with positive feedback received.

Strategic Planning – Goals for the year

The committee has held an annual planning meeting for the past 2 years, early in December, to establish its goals and plan for the coming year. Some of our key goals for the year included:

Education Events/Forums

 11 April 2015 Oral Cancer Agents Breakfast seminar was held on a Saturday morning at the Hilton Hotel in Adelaide's CBD and attracted 41 attendees. A medical oncology Nurse Practitioner and a senior Oncology Clinical Pharmacist spoke about some of the issues and

- important aspects of safety, monitoring and patient education surrounding oral chemotherapeutic agents.
- 1 September 2015 Dinner meeting 'Its not just breast cancer.... it's in the details' was an enthusiastically attended dinner where Dr Ganessan Kichendasse, a medical oncologist at the Flinders Centre for Innovation in Cancer spoke on gene mutations and amplifications in breast cancers and how they predict treatment. We also heard from a Breast Care Nurse Practitioner and a country McGrath Nurse, who was so keen to share her experiences with us and offer her support with our country patients that she did the entire 315Km journey in the one night, after a full day of work! 55 attendees.
- 12 November 2015 A panel forum with a light supper— 'Q & A.... Your cancer nursing career' A panel of engaging speakers who were chosen for their current positions in hospitals, the community and non-government organisations working in the area of cancer care. All nurses, they were asked to speak about their path to their current role; to share what they've learnt and what they might have done differently had they known then what they know now. From the ward, to management, teaching, trials and an advocacy role, attendees enjoyed presentations that similarly highlighted the friendships each made along the way; there's an interesting kind of bonding that occurs over difficult patients, seemingly unbendable bureaucracy and unspeakable tasks shared on night duty! 32 attendees. An AGM followed the panel discussion.
- 20 February 2016 Breakfast Seminar 'Lung Cancer.... Today' Held at the iconic 'cheese grater' South Australia's Health and Medical Research Institute (SAHMRI). Two speakers from both a nursing and a medical background spoke. Assoc. Prof Dusan Kotasek, one of the founding partners of the largest private tertiary referral cancer centre in SA presented on Lung Cancer, specifically the landscape as it stands today in NSCLC and some of the gene mutations and sequencing that have appeared more recently. His presentation was enthusiastically received with an engaged audience openly participating in discussion. Despite some timing and catering glitches on the day, the evaluations where overwhelmingly positive...phew! 51 attendees.

Communication to Members

Events are communicated to both members and non-members at scheduled time frames prior to events. This service provides an online registration program, collation of details and creation of all event-marketing materials for each event. The mailing list is maintained by the Chair, Deborah Hoberg, at the current time and is comprised of both members and attendees of events who are non-members with the addition of some key people in cancer care in SA, both metropolitan and rural.

Reporting – Newsletters, Financial Report

General - Our Deputy Chair Alicia Hopper looks after our communications and social media presence. This includes a quarterly SA e-newsletter as well as biannual contributions to the national e-newsletter and any posts on the national Facebook & Twitter feeds.

Financial -All funds previously held locally have been transferred to the National CNSA account and all bookkeeping and auditing processes are now done at a national level in keeping with the RG & SPN Finance Manual.

SA is one of the RGs trialling our own debit card and is documenting any issues with this process as they arise. An evaluation of this trial will be discussed at the RG & SPN Chairs meeting at Congress in May.

Since my last report, the Breast Oncology Specialist Practice Network (Breast SPN) has grown to 283 members, a significant increase of over 100 new members (174) in the last 12 months. This increase may in part be due to the successful integration of the breast care nurse conference into the CNSA Winter Congress in Perth. The breast care nurse symposium was well attended, and apart from a few small glitches on the day, the evaluation responses overwhelmingly supported the continuation of the breast care nurse conference in this format.

In this regard, we are very excited to announce that the 2016 Cairns Congress Breast Symposium is a joint collaboration between CNSA and the McGrath Foundation. We sincerely hope that the conference delegates benefit from the calibre of the international and national guest speakers and educational workshops that will be available during the Congress.

During the Breast SPN meeting, the academic expiry of the Specialist Breast Nurse Competency Standards that were published in 2005 by the then NBOCC were discussed, with the possibility of lobbying Cancer Australia to review and republish these guidelines to reflect current Breast Care Nurse (BCN) practice. Unfortunately, the preliminary discussions with Cancer Australia in getting these guidelines updated indicated that this was not likely to occur, therefore, any further plans relating to these competency standards will be shelved with BCN's encouraged to familiarise themselves with the National Competency Standards for Registered Nurses that have recently been released but the Nursing and Midwifery Board of Australia.

Planning is underway to begin the process of reviewing and republishing the CNSA Principles for Nursing Practice in the Management of Post-Surgical Seroma for Breast Cancer guidelines. As you imagine this is a very time consuming process and I will keep you informed of the progress of this project as it's made. I thank those of you who have already indicated their desire to participate in this project, and hope at the time of the SPN meeting during the Cairns Congress that I am able to provide more detail and project progress.

Associations with stakeholders such as Cancer Australia, Breast Cancer Network Australia and the McGrath Foundation continue, with active participation in strategic planning and advisory groups as required. The SPN is also actively involved with the University of NSW in applying for funding to develop a web based ductal carcinoma in situ (DCIS) patient resource tool.

Thank you to all that have provided me with support and direction during the last year as Chair of the Breast SPN. It has been quite a steep learning curve for me, and full of exciting opportunities and challenges. I look forward to the next 12 months.

The Cancer Nurses Society of Australia Incorporated Notes to the Financial Statements For the year ended 31 March 2016

The financial report covers The Cancer Nurses Society of Australia Incorporated as an individual entity. The Cancer Nurses Society Australia is an incorporated association incorporated and domiciled in Australia.

The principal activities of the Society during the year was to act as a resource to cancer nurses around Australia through the provision of services which aim to advance cancer nursing education, practice and research.

The functional and presentation currency of The Cancer Nurses Society of Australia Incorporated is Australian dollars.

Comparatives are consistent with prior years, unless otherwise stated.

Note 1. Basis of Preparation

In the Executive Committee members opinion, the Society is not a reporting entity since there are unlikely to exist users of the financial report who are not able to command the preparation of reports tailored so as to satisfy specifically all of their information needs. This special purpose financial report has been prepared to meet the reporting requirements of the *Australian Charities and Not-for-profits Commission Act 2012*.

The financial statements have been prepared in accordance with the recognition and measurement requirements of the Australian Accounting Standards and Accounting Interpretations, and the disclosure requirements of AASB 101, Presentation of Financial Statements, AASB 107 Statement of Cash Flows, AASB 108 Accounting Policies, Changes in Accounting Estimates and Errors and AASB 1054 Australian Additional Disclosures.

Note 2. Summary of Significant Accounting Policies

The accounting policies that have been adopted in the preparation of the statements are as follows:

(a) Income Tax:

The Society is exempt from the payment of income tax pursuant to Section 50-5 of the *Income Tax Assessment Act (1997)*.

(b) Revenue and other income

Revenue is recognised when the amount of the revenue can be measured reliably, it is probable that economic benefits associated with the transaction will flow to the Company and specific criteria relating to the type of revenue as noted below, has been satisfied.

Revenue is measured at the fair value of the consideration received or receivable.

All revenue is stated net of the amount of goods and services tax (GST).

2 Summary of Significant Accounting Policies continued

Donations

The Society, in common with most organisations dependent upon contributions, is unable to establish control over voluntary donations prior to their initial entry into the accounting records, therefore they are recorded on the basis of cash received.

Member Subscriptions

Member subscriptions are recorded on an accruals basis and apportioned across the calendar year of membership.

Grants and Bequests

The Society receives grants and bequests for certain activities. Where a grant or bequest is non-reciprocal, it is recognised as revenue of the Society upon receipt. Associated expenditure for the completion of a grant or bequest is recorded as incurred. Where a grant or bequest is subject to a reciprocal transfer, a liability associated with the reciprocal transfer is recorded upon receipt of the transfer. The income and expenditure is then subsequently reported at the time of the subsequent of the grant or bequest.

Interest Revenue

Interest is recognised using the effective interest method.

Other Income

Other income is recognized on an accruals basis when the Society is entitled to it.

Net Annual Congress Income

The Society contracts a professional Events Co-ordinator to manage the staging of the Annual Congress including the receipt of revenue and payment of expenses in relation to the event. Documents detailing the income and expenses have been received from the Events Co-ordinator together with a reconciling statement. Revenues and expenses associated with the Congress are recognised through the Statement of Profit & Loss and Other Comprehensive Income in the year the Congress is conducted. In the period in the lead up to the Congress, expenditure is incurred and income received which is taken up as prepayments and unearned income respectively.

(c) Goods and services tax (GST)

Revenue, expenses and assets are recognised net of the amount of goods and services tax (GST), except where the amount of GST incurred is not recoverable from the Australian Taxation Office (ATO).

Receivables and payable are stated inclusive of GST.

The net amount of GST recoverable from, or payable to, the ATO is included as part of receivables or payables in the statement of financial position.

Cash flows in the statement of cash flows are included on a gross basis and the GST component of cash flows arising from investing and financing activities which is recoverable from, or payable to, the taxation authority is classified as operating cash flows.

2 Summary of Significant Accounting Policies continued

(d) Property, plant and equipment

Each class of property, plant and equipment is carried at cost less any accumulated depreciation and impairment.

Items of property, plant and equipment acquired for nil or nominal consideration have been recorded at the acquisition date fair value.

Depreciation

Property, plant and equipment is depreciated on a straight-line basis over the assets useful life to the Company, commencing when the asset is ready for use.

The estimated useful lives used for each class of depreciable asset are shown below:

Fixed asset class	Useful life
Office Equipment	3 years
Computer Equipment	3 years
Web site Development	3 years

At the end of each annual reporting period, the depreciation method, useful life and residual value of each asset is reviewed. Any revisions are accounted for prospectively as a change in estimate.

(e) Cash and Cash Equivalents:

Cash and cash equivalents include cash on hand, deposits held on call with banks and other short-term highly liquid investments with original maturities of three months or less.

(f) Employee benefits

Provision is made for the Company's liability for employee benefits arising from services rendered by employees to the end of the reporting period. Employee benefits that are expected to be wholly settled within one year have been measured at the amounts expected to be paid when the liability is settled.

(g) Income in Advance:

Income in Advance includes member subscriptions, which have been received for the 2016 membership year, (Refer to note 2 (b)) and Annual Congress income received (Refer to note 2 (b)) or other future income such as sponsorships, which may cover the full proceeding calendar year.

(h) Comparative Figures:

Comparative figures have been adjusted to conform to changes in presentation for the current year where required by accounting standards or as a result of changes in accounting policy.

(i) Other Current Assets:

Prepayments included in other assets primarily relates to prepayments for the future Annual Congress.

(j) Trade and Other Payables:

Trade and other payables represent the liabilities for goods and services received by the Society that remain unpaid at year-end. Trade payables are recognised at their transaction price. They are subject to normal credit terms and do not bear interest.

3 Critical Accounting Estimates and Judgments

The National Executive make estimates and judgements during the preparation of these financial statements regarding assumptions about current and future events affecting transactions and balances.

These estimates and judgements are based on the best information available at the time of preparing the financial statements, however as additional information is known then the actual results may differ from the estimates.

The significant estimates and judgements made have been described below.

Key estimates - receivables

The receivables at reporting date have been reviewed to determine whether there is any objective evidence that any of the receivables are impaired. An impairment provision is included for any receivable where the entire balance is not considered collectible. The impairment provision is based on the best information at the reporting date.

Note 4. Nature and objects of the Society:

The Society is an association incorporated under the Associations Incorporation Act 1991. Its object is to determine and regulate professional standards and competencies for cancer nursing practice and education, facilitate research and standards in the area of cancer nursing, act as a resource for the development and dissemination of information relating to new technologies in cancer nursing, ensure that cancer nurses perspectives' are evident in national nursing debates, actively lobby government on issues relevant to cancer nursing and collaborate locally, nationally and internationally with other organisations involved in the development and provision of services to people with cancer.

In the event of the Society being wound up, the members undertake to contribute to the assets an amount not exceeding the ordinary membership fee of the Society.
